Chaplain Darrell Wesley is a native of Chattanooga TN and the grandson of a Baptist preacher. He possesses the heart of a pastor and the mind of a scholar and serves the Kingdom of God in a myriad of ways.

Chaplains Wesley preached his first sermon at the age of 11 under the mentoring of the late Minister Carl Taylor. At 21 years old, he served as pastor for his first church and since then, has served as pastor for three churches. He is currently an ordained minister in the Christian Methodist Episcopal Church.

For the last 16 years he has served as an active duty Navy chaplain currently possessing the rank of Commander and serves as senior chaplain for the Eleventh Coast Guard District in Alameda, CA.

Chaplain Wesley's previous military assignments included Staff Chaplain, Naval Air Engineering Station, Lakehurst, NJ; Submarine Base, New London, Groton, CT; USS Support Group, Port-au-Prince, Haiti; USS Gettysburg, Mayport, FL, and Third

Marine Aircraft Wing, Miramar, CA. His personal decorations include the 2 Navy and Marine Corps Commendation Medals, 2 Navy and Marine Corps Achievement Medals, Joint Service Achievement Medal, Army Achievement Medal, and other medals and awards.

Chaplain Wesley has proven to be an astute scholar with an impressive academic record. He received his Bachelor of Arts degree in English and a Masters degree in Bible from Abilene Christian University. He also earned a Master of Arts in Philosophy from the University of Tennessee and a Masters of Sacred Theology from Yale University with a concentration on Black Theology, Liberation Theology, and the Philosophy of Religion. He holds a Doctor of Ministry Degree from United Theological Seminary, with a concentration on liturgical theology. He also possesses a PhD from the prestigious Claremont Graduate University. His PhD dissertation, entitled "Towards a Postmodern Ethic: A Foucauldian Reconstruction of the Epistemology and Metaphysics of Cornel West," offers a theory of radical freedom that ensures flourishing for the most vulnerable in society. Chaplain Wesley has served as ethics professor at the Naval Postgraduate School in Monterey, California and as adjunct professor for Barstow College and Central Texas College.

Chaplain Wesley recently received orders to serve as senior chaplain on the USS Ronald Reagan.

This contribution involves a number of highly successful programs, including; youth mentoring, academic tutoring, and awarding of financial scholarships to college bound high school seniors.

Hadwick and Lily Thompson Scholarship Award Criteria

<u>Eligibility Requirements</u>: Bay Area high school senior entering an accredited college or university during the 2010-2011 academic year are eligible. You must be a U.S. citizen and have a minimum grade point average of 2.5 on a 4.0 scales (or equivalent). **Please submit your completed package to the address listed below no later than 01 April 2011.** Scholarship recipients will be notified no later than **07 May 2011.**

<u>Details of Award</u>: This one-time award aims to grant an ethnic-based scholarship to a student entering college as a freshman during the 2010-2011 academic year. The recipient will be selected and announced in May 2011.

Award Amount: \$1000

Package Requirements: You are required to submit the following:

- A completed application
- An official high school transcript (with school's official seal).
- > Two Letter(s) of recommendation from an individual you know, such as a school official (principal, guidance counselor, coach, etc...) or an official from an organization. These letters should address your potential academic performance at the collegiate level. It should also state your relationship to the official and note any noteworthy/significant accomplishments.
- Three Counselor/Teacher Evaluation Form(s). Evaluation forms must be mailed by the individual completing the evaluation directly to NNOA. (It is recommended that you provide a stamped, pre-addressed envelope to individual completing evaluation to expedite mailing of the document).
- A typed 100 to 300-word essay discussing your educational and career goals
- A current photograph (3" x 5" minimum). Photos will not be returned.
- Copy of ACT and SAT results

Failure to submit ALL requested information will result in disqualification. Students submitting incomplete packages will be notified. All qualified applicants will also be notified of eligibility for an NROTC scholarship.

Buckles, last WWI doughboy, dies at 110 in W.Va.

Buckles enlisted in the United States Army at 16. He died Sunday on his farm in Charles Town, nearly a month after his 110th birthday. He had devoted the last years of his life to campaigning for greater recognition for his former comrades, prodding politicians to support a national memorial in Washington.

According to the Order of the First World War, a Florida group whose members are descendants of WWI veterans, only two known veterans remain, Florence Green of Britain and Claude Choules of Australia,. Choules was born in Britain and served in Britain's Royal Navy, but now lives in Australia. Green turned 110 on Feb. 19, 2011 and Choules turns 110 in March 2011.

Buckles was born in Missouri in 1901, and raised in Oklahoma. After being rejected by many military recruiters, Buckles was enlisted in the United States Army in 1917.

More than 4.7 million people joined the U.S. military from 1917-18. By 2007, only three survived. Buckles went to Washington that year to serve as grand marshal of the national Memorial Day parade.

Unlike Buckles, the other two American survivors were still in basic training when the war ended, and they did not make it overseas. When they died in late 2007 and 2008, Buckles became the last so-called doughboy — and a soft-spoken celebrity.

The surviving family has asked that Buckles be buried in Arlington National Cemetery, and President Barack Obama ordered that the day Buckles is buried that all U.S. flags on official buildings be lowered to half-staff.

Buckles had already been eligible to have his cremated remains housed at the cemetery. Burial, however, normally requires meeting several criteria, including earning one of five medals, such as a Purple Heart. Buckles never saw combat and did not receive a medal of such distinction.

Sen. Joe Manchin said, "Buckles lived a long and rich life as a true American patriot". The family asked that any donations be made to the National World War One Legacy Project. The project is managed by the nonprofit Survivor Quest and will educate students about Buckles and WWI through a documentary and traveling educational exhibition.

The January 2011 edition of The Journal reported that the gymnasium at Coast Guard Island Alameda would be named in honor of Emlen Tunnell, a Coast Guard Steward's Mate First Class who served during WWII (1943-46) and was personally responsible for saving the lives of two shipmates on two separate occasions; once when pulling Machinist Mate First Class Fred Shaver to safety when a Japanese torpedo ignited a fire on the USS Etamin, and again when shipmate Alfred Givens fell off the dock of Coast Guard Cutter Tampa Emlen jumped in freezing 32-degree seas to effect the rescue of a shipmate in distress. Emlen suffered injury to himself during both rescues.

On March 9, 2011 the Coast Guard conducted the gymnasium dedication ceremony before hundreds of local citizens, civic leaders, and honored guests that included Emlen's sister Mrs. VivianTunnell Robinson, niece Catherine Robinson, and daughter of rescue victim Nancy Shaver. Members of the Hayward NAACP office were also in the audience, along with legendary Oakland Raider defensive back Willie Brown.

Members of the official party included The Honorable Marie Gilmore, Mayor of City of Alameda, Commander William Makell, Jr., Coast Guard Headquarters Ethic Policy Advisor, and keynote speaker/presenter Rear Admiral Joseph Castillo, Commander Eleventh Coast Guard District. Commander Darrell Wesley, Chaplain, U.S. Navy provided the benediction.

In addition to naming the gymnasium, the Silver Lifesaving Medal was awarded to Steward's Mate First Class Emlen Tunnell for his gallantry in saving the lives of two shipmates. The medal was presented by RADM Castillo to Mrs. Vivian Robinson. Emlen was also awarded the Combat Action Ribbon for service on the USS Etamin during WWII.

Memorabilia from Emlen's NFL playing days was donated by the NFL Hall of Fame, Coast Guard uniform items were provided by Mrs. Vivian Robinson and the Tunnell family, and replicas of the Silver Lifesaving Medal and Combat Action Ribbon will be permanently displayed in the gymnasium lobby while a bronze dedication plaque will be proudly displayed at the main entrance to the gymnasium.

Marion Motley

Marion Motley (June 5, 1920 - June 27, 1999) was a NFL football player who played for the Cleveland Browns, and briefly for the Pittsburg Steelers

Motley attended high school at Canton McKinley
High School in Canton, Ohio, and played
college football at South Carolina State and
Nevada. Motley joined the U.S. Navy in 1944,
and first played for Paul Brown with the Great
Lakes Naval Training Station Bluejackets. This
team, full of fine players who had enlisted for World
War II, notably defeated Notre Dame 39-7 in 1945.
Motley planned on going back to college to get a
degree, but then Paul Brown offered him a job with his
new professional team. He started his pro football
career in 1946, when the Cleveland Browns were part
of the new All-American Football Conference (AAFC).

Motley and the Browns won every championship in the four-year existence of the AAFC, posting an overall 47-4-3 record, including an undefeated 15-0 season in 1948. Besides the New York Yankees and San Francisco 49ers, the other teams in the AAFC did not offer significant opposition to the Browns. In the 1946 AAFC championship game against New York, Motley rushed for 98 yards on 13 carries, including a

touchdown, as the Browns prevailed 14-9. In the 1947 rematch, Motley rushed 33 times for 109 yards in the Browns' 14-3 win. In the 1948 championship game against the Buffalo Bills (who won the AAFC East title with a 7-7 record), Motley carried 14 times for 133 yards and three touchdowns, as the Browns romped 49-7. He wrapped up his AAFC career in the 1949 title game against San Francisco.

When the AAFC shut down after 1949, Motley was the league's career rushing leader at 3,024 yards. The Browns joined the NFL in 1950 and that season Motley led the league in rushing with 810 yards on 140 carries. That October, he set a record that lasted over 52 years when he averaged over 17 yards per rush against the rival Steelers, with 188 yards on 11

carries. To qualify for that singlegame record, a player must have a minimum of 10 carries. In December 2002, quarterback Michael Vick of the Atlanta Falcons rushed for 173 yards on 10 carries against the Minnesota Vikings, eclipsing Motley's average by 0.21 yards per carry.

Motley was also

an outstanding pass blocker and played linebacker on defense. He retired from the NFL before the 1954 season. After a year off he returned and played in 1955 with the Steelers, but retired again after a few games due to more injuries.

After retiring he scouted players for the Browns, and wanted to coach. At the time, racism frequently prevented minorities from obtaining coaching jobs and he was turned down on most offers.

In 1968, Motley was voted into the Pro Football Hall of Fame. The previous year, former safety Emlen Tunnell, who served in the Coast Guard during WWII, of the New York Giants was the first black player to achieve the honor, making Motley the second.

History of the Discharge Certificate

For those of you exploring your family heritage and searching for military information about a family member, this article may be of use. It has been a big help to me. Come to find out I have had a relative fight in every American war and conflict.

The Declaration of War on December 8, 1941, and Legislation enacted by the Congress in furtherance of the Declaration of War requires the continuance in service of every Officer and

Enlisted Man of the Army for the duration of the Emergency, and for a period of 6 months thereafter, unless sooner released from service by proper authority. Releases from active service will be granted only when in the interest of the Government or when the necessity therefore is extreme.

No Enlisted Man lawfully inducted into the Military Service of the United States shall be discharged from the Service without a Discharge Certificate. No Discharge Certificate is given an Enlisted Man upon Retirement, nor upon being dropped from the Rolls, because of being a deserter from Army, Navy, Marine Corps or other cause. Discharge is a release as a member of the Army, upon completion of his Term of Service or for such reasons as.

disability – minority – inaptitude – or conviction. The type of Certificate issued gives the character of the Service and the reason for Discharge.

There are 3 different Forms of Discharge Certificates:

Honorable Discharge: This Certificate (i.e. W.D., A.G.O. Form No. 55) called Honorable Discharge from the Army of the United States, is printed on white paper, and therefore sometimes referred to as a White Discharge. It will be given to every soldier upon Discharge. It is given to an EM whose Service has been honest & faithful, and who has been given a

character rating of good, very good, or excellent. The Enlistment Record (printed on the back of the Discharge Certificate) is signed by the Personnel Adjutant who is the custodian of the soldier's Service Record – it must be completed in a neat and legible way, either by typewriter or in longhand, with pen and ink, and will not bear any erasures and corrections – it must be exact, not altered, and presentable, so as to reflect the official record of Service furnished by the

discharged man. A Service Certificate will be given to any member of any Reserve component of the Army who satisfactorily completes his required term of active Military Service in the Army of the United States, or who is honorably separated from the Military Service or honorably relieved from active Federal Service, prior to the completion of the required Service period! The 'character' entered on the Service Record at the completion of this period should be 'good' or better (any individual who fails to qualify under the requirements given above, will NOT be issued a Certificate of Service)!

Discharge from the Army of the United States: This Certificate (i.e. W.D., A.G.O. Form No. 56) called Discharge without Honor from the Army of the United States, is printed on blue paper, and therefore sometimes referred to as a Blue Discharge. It is given when

the Service has not been honest & faithful, and when a character rating is fair or poor, or when a Dishonorable Discharge cannot be given! It will be given under following conditions:

- For Fraudulent Enlistment
- Dishonorable Discharge by a Court-Martial
- For Inaptness, or Undesirable Habits or Traits of Character, pursuant to the approved proceedings of a Board of Officers in all other cases of Discharge (except Dishonorable Discharge), when the CO is of the opinion that the EM's service has not been honest and faithful.


Continue, Discharge Certificate...

Dishonorable Discharge: This Certificate (i.e. W.D., A.G.O. Form No. 57) called Dishonorable Discharge from the Army of the United States, is printed on yellow paper, and therefore sometimes referred to as a Yellow Discharge. It will be given in case of a formal release from Military Service, without honor, and to every man Dishonorably Discharged pursuant to a Sentence of a Court-Martial or a Military Commission.


Remark: There is also a Discharge by Purchase, given ONLY in time of peace to an EM in good standing, who has completed 1 year or more of Service, and is not undergoing punishment or court-martial charges, and when he has paid the required fee for release from further Service. (Suspended, during the existing Emergency)

Clothing & Equipage for Servicemen with Honorable Discharge or Inactive Duty Status:

Upon the Discharge of EM or EW, all uniform outer clothing then in his/her possession, except such articles as he/she may be permitted to wear from the place of termination of his/her active service to his/her home, as authorized, will be retained for military use (AR 615-40).



Upon being Honorably Discharged or placed on Inactive Duty Status, Enlisted Man or Enlisted Women (with exception of those discharged to accept an officer's commission, or an appointment as warrant officer, or flight officer), will be permitted to retain permanently in their possession, without regard to climate, season, or location, certain government




clothing items and equipage such as belt, shoes, gloves, trousers, socks, etc.

Enlisted Personnel (EM & EW) who are discharged to accept an Officer's Commission, or an appointment to Warrant or

Flight Officer, are authorized to permanently retain the prescribed allowances of –handkerchiefs, neckties, service & low quarter shoes, socks, toilet articles, towels and underwear and/or anklets, gloves, stockings, neckties, field & service shoes, toilet articles, towels and underwear.

When Enlisted Personnel is discharged otherwise than Honorably, ALL uniform outer clothing shall be retained for military use, except following items –1 necktie, 1 shirt, 1 pair service shoes, 1 underwear set, all handkerchiefs, socks, stockings, toilet articles, and towels ... (issue from stock of 1 each of above listed item is authorized if such items are not in possession of the individual).




Lou Gertha Bonner Memorial Fund
